

**PARTICIPANT RELEASE FORM FOR “MY SOURCE” INITIATIVE
FOR**

 (“Station”)

For good and valuable consideration, the receipt and sufficiency of which I hereby acknowledge, the “Station Partners” (described below) may use my name, biographical information, voice, photograph, likeness, performance, electronic and written communications and any interviews and recordings which are made by me or of me in connection with the “My Source” initiative. All audio and/or video recordings, photographs and any electronic or written communications made by me or of me in connection with the “My Source” initiative are referred to in this Release form as my “**Performance**”. The Station Partners may use my Performance for any commercial or non-commercial purpose in any and all media now known or developed in the future, throughout the world, in perpetuity, royalty-free. “**Station Partners**” means the Station identified above, the Corporation for Public Broadcasting (“**CPB**”), the advertising and marketing agencies of the Station and the CPB, any public broadcasting entity eligible to receive funding from CPB (including radio and television stations), and the licensees, successors, directors, officers, employees, parent, subsidiaries, affiliates and assigns of each of the foregoing.

The Station Partners may make any use of my Performance, including but not limited to the following:

1. Broadcast my Performance or make a recording for broadcast at a later time and for archival purposes.
2. Edit, adapt, modify, excerpt and revise my Performance in any way.
3. Combine my Performance with the Performance of other individuals.
4. Provide a copy of my Performance to any person or commercial or non-commercial entities.
5. Distribute my Performance live or on-demand via the Internet and/or any other digital media, audio, text, and visuals obtained during the recording.
6. Assign copyright of my Performance to another entity, including for a fee.
7. Use my Performance in advertising in any media including print, outdoor, T.V. and online.

The Station Partners may do any or all of the foregoing without any payment to me. Any revenues received by a Station Partner for furnishing my Performance to another person or entity shall belong entirely to such Station Partner.

I expressly acknowledge that I am knowingly and voluntarily taking part in the My Source initiative.

I acknowledge that I have carefully read this document in its entirety and confirm that I have the full power and authority to enter into this agreement and that I accept it of my own free will.
